

WESTERCON SITE SELECTION BALLOT

Voting for the Westercon Site Selection shall consist of **(1)** filling out this ballot; **(2)** paying a fee of **\$20 USD** and **(3)** turning in this ballot to the current Westercon Committee for tabulation.

Voting is done by the “preference” method. Once you have chosen the site you wish to vote for, place a “1” next to that site. Place a “2” next to your second place, a “3” next to your third choice etc., until you have either run out of choices or do not wish to vote further. If there is a mark next to only 1 site, the ballot shall be counted as having cast a 1st choice vote for that site. Any ballot which has marks other than as described above shall be disqualified for the count.

Votes will be tallied by the voters' 1st choices. If no majority is obtained, the site which places last in the initial tallying shall be eliminated and the ballots listing it as 1st choice shall be redistributed on the basis of those odds ballots' 2nd choices. This process shall be repeated until a majority has been obtained.

Completely fill out Part 1 and Part 2. It is not necessary to complete Part 3. Your check will be your receipt.

The clerk will take your money, fill out **Part 3** as your receipt and cut apart Parts 1,2 and 3. You will be given back **Part 2** and **Part 3**. **Now** fill out **Part 2** and place it in the **Ballot Box** at the **Site Selection** table. Keep **Part 3** as your receipt.
